AGENCY / MEMBER AGREEMENT

(HEREIN REFERRED TO AS AGENCY)

AND

(HEREINAFTER REFERRED TO AS MEMBER)

For and in consideration of the mutual promises herein contained, the parties hereby agree as follows.

For the term of this agreement, Member hereby appoints and engages Agency to act as Member's exclusive personal manager in the fields of Modelling, advertising, acting and entertainment. (Hereinafter referred to as the "fields").

During the term hereof, Agency shall advise and counsel Member in the selection or consideration of career opportunities, photographers, advertisers, castings and the selection or creation of vehicle of Member in any way and all matters pertaining to publicity, public relations, advertising talents of Member and shall advise Member on composites (comp cards) and the formation of portfolio.

Member agrees to seek Agency's counsel in regards to all matters concerning Member's endeavours in the fields. Member shall advise Agency of all offers of employment submitted to Member and will refer all inquiries concerning Member's services to Agency.

Agency is hereby granted the exclusive right to use and distribute and allow or license others to make use of and distribute Member's name, portrait and pictures in connection with advertising and/or publicity of the member in the fields and in connection with the matter covered by the agreement.

Agency may publicize that it is the personal manager of the Member, and Agency may render similar services for others, and engage in other related business or ventures.

Member agrees to provide Agency with current photographs, comp card tear sheets/advertising, written or other related material for promotional use of the Agency and the Member.

Member shall pay to the Agency a sum of twenty five per cent (25%) of all monies, fees or other contributions received by Member directly or indirectly, under all contracts of employment entered into during the term specified in paragraph ten (10) and subsequently, paragraph eleven (11), including reuse and residual whether originated by Agency or not.

Member hereby grants to Agency a limited power of attorney to collect all fees and monies earned or accruing to member from all sources governed by this agreement and to remit to member the net fee after deducting the foresaid twenty five per cent (25) commissions.

This limited power of attorney includes the right of the Agency to deposit the proceeds in a general account prior to remitting the balance to Member.

Member agrees to instruct the clients, producers, advertising agencies, production houses and/or union office in writing on the face of all job contracts or on the release, Member signs at the time of the production to send all fees and monies due to the Member directly to the Agency.

This limited power of attorney also authorizes Agency to sign Member releases on behalf of the Member and authorize, reuse and residuals whether originated by Agency or not.

It is understood and agreed that Member is in business for himself/herself and is solely responsible for payment of any and all taxes, whether income or otherwise.

It is further understood and agreed that Agency is acting as a personal manager only and does not operate as an employment agency.

The term of this agreement shall be made for a period of two years (2 years), commencing this date. Member may terminate this agreement with 90 days written notice, delivered by registered mail to the address listed on the face of this document.

If termination notice is received after a booking or placement has been arranged, Member agrees to honour that booking /placement or else reimburse the Agency for any and all costs incurred or revenue forfeited (including such revenue which may be owing to a client due to incurred expenses as a result of Member Cancellation.

In the absence of termination notice, this agreement shall continue to be renewed from year to year on anniversary date.

Member is aware that Agency is entitled to receive a service charge from some or all the clients who utilize Member's services. Member and Agency agree that this service charge will not affect Member's reimbursement.

In acting as a Member's personal manager, it is understood that Agency will use reasonable efforts to assist Member obtain sub-agency placement outside province of Gauteng in such cases it is understood that with respect to such engagements, Member need not compensate Agency as provided in paragraph seven (7) hereof, although it is understood that the Agency may be entitled to receive compensation from such sub-agencies.

Member agrees to conduct himself/herself with propriety and dignity, to do nothing on an engagement or otherwise that may tend to injure the reputation and goodwill of Member or Agency, not to do any act or thing which impairs Member's capacity to at all times fully comply with the terms of this agreement, or which impairs member's physical or mental qualities or abilities.

Member further agrees to abide by all standard rules and policies of casting and engagement. Agency may upon five (5) days' notice to member terminate this agreement for breach of this paragraph.

Member understands and agrees that Member shall not, while this agreement is in force, enter any modelling/acting /advertising contests or competition organised or sponsored by any company other than that agency or sign and contest agreement unless Member has a written permission of Agency.

Waiver by either of the parties hereto of a breach of any of the provisions herein shall not be deemed a waiver of any subsequently breach nor a modification of such provision.

It is understood and agreed that Member's services are extraordinary and unique and there is no adequate remedy at law of a breach of this agreement by Member and that in the event of such a breach or threatened breach, Agency shall be entitled to injunction or otherwise provided however that nothing herein shall be construed as a waiver of any or all rights which Agency may have for damages in an action at law or in equity or otherwise.

This covenant sets forth the entire engagement between parties. Should any provision(S) be held to be void or unenforceable, such provisions shall be deemed omitted and this agreement with such

provisions omitted shall remain in full force and effect.

No modification, alteration or amendments of any provisions contained herein shall be valid or binding unless in writing by both parties hereto, both parties warrant that in entering into this agreement they have not been induced by and are not relying on any promises, representations or warranties not set forth in writing. Member warrants that no other binding agreement is in force with any other party which should supersede this agreement. This agreement shall be binding upon both parties hereto, their heir, successors, assigns etc.

BY SIGNING BELOW, BOTH PARTIES AGREE TO THE TERMS CONTAINED WITHIN THIS AGREEMENT AND ACKNOWLEDGE UNDERSTANDING OF THE TERMS OF THE CONTACT HEREIN.
